ANALYSIS OF THE EUROPEAN FUNDS ABSORPTION FOR RURAL DEVELOPMENT IN ROMANIA

Abstract

The paper studies the absorption of European funds and the payments made under The National Programme for Rural Development in Romania. Article begins with an introduction that refers to the importance of rural and European Common Agricultural Policy, the changes in the CAP related to rural development, it presents the differences between countries within the European Union and how these disparities can be reduced. It is a study of the four priority axes and measures included, as well as the value of public and private contributions allocated to Romania for the period 2007-2013. It is analyzed the progress in which it are payments for rural development in Romania for each axes and measures both numerical value and percentage reported to the total public contribution. Finally some conclusions on the progress results in which it is Romania regarding payments made for finance projects submitted by the end of 2010. The results of this analysis can be used to form a clear image of access to European funds for rural development in Romania.

Introduction

The purpose of this article is to perform an analysis of European funds for Romania's access to rural development and to do a study on the value of payments at the country level by the end of 2010. Throughout the article provides a dual analysis: there is a situation on axis and measures regarding payments made in 2010 reported only to the total amount of public contribution and value of total payments made up to 31.12.2010 reported in total public contribution and another analysis that includes the payments made by axes relative to the total public contribution and value of payments relative to total public contribution earmarked for measures open to submission of projects

(in Romania, during the 4 axes are measures established by the National Rural Development Programme which were not yet open submission of projects which are due to be implemented after 2010). This study is done based on official documents taken from the Ministry of Agriculture and Rural Development in Romania and the Payments Agency for Rural Development and Fisheries on the situation of projects on submission session.

Rural development as component of the CAP as gained attention after the Commission's development of strategic document Agenda 2000, becoming the second pillar of CAP. There are two major reasons justifying the need for an approach in this direction: the first is given the very high proportion - 80% - which hold agricultural land area relative to the European Union. The second is the primary objective of economic and social cohesion of the European Union, whose implementation would be utopian without due attention to the harmonious development of rural areas.²

Considerable simplification has been introduced in the new programming period 2007-2013 as compared to the previous one. Rural Development is now financed by a single fund: the European Agricultural Fund for Rural Development.

As before 2007, every Member State (or region, in cases where powers are delegated to regionallevel) must set out a Rural Development Programme, which specifies what funding will be spent on which measures in the period 2007 to 2013.³

In Romania, for the period 2007-2013, the rural development is supported through implementation of National Rural Development Programme (NRDP). NRDP is the tool to access the European Agricultural Fund for Rural Development (EAFRD) and was developed for the period 2007 to 2013, by the Managing Authority for the National Rural Development Program of the Ministry of Agriculture and Rural Development in Romania in accordance with Article 16 of Council Regulation no. 1698/2005 and the Community Strategic Guidelines for Rural Development.⁴

The main thematic axes and the allocation of funds under National Rural Development Programme of Romania for 2007-2013

Overall economic and social context of the implementation of the NRDP 2007-2013 is more complex than expected before its preparation. Given the increasingly competitive environment after joining the European Union, issues such as competitiveness and economies of scale will become increasingly critical for rural development and

agriculture in Romania.

Therefore, the National Rural Development Programme 2007-2013 focuses on strengthening competitiveness and the economy of scale, but also take into account the need to protect nature, environment, natural resources, soil, water in rural areas and improving quality of life for rural residents.⁵

Programming support operations through the National Rural Development Programme is focused on four priorities:

- Axis 1 Improving the competitiveness of agricultural and forestry sector to increase efficiency of agriculture and forestry to prepare it to meet specific competition open trading environment. Support will be directed to small and medium enterprises, considered to be more able than large companies to develop new products, to better exploit local resources through innovation and adaptation. Priorities within this axis chosen taking into account the development needs and the need to continue some of the pre-accession measures.
- Axis 2 Improving the environment and the countryside the general objective of Axis 2 measures is to improve the rural environment and conserve biodiversity through sustainable management of agricultural and forest land. Also by this axis measures encouraging the adoption of measures to protect soil against erosion processes (eg establishment of crops Green).
- Axis 3 Quality of life in rural areas strategic objectives of this axis have regard to the quality of life in rural areas, diversification of rural economy, promoting knowledge and improving human potential. This axis measures aimed at the broader rural community of developing businesses in rural areas based on natural resources, tourism, village development and environmental initiatives to complement the measures in the farm and to provide alternative employment opportunities for rural population. These measures were chosen according to the weaknesses of rural areas (low income, excessive dependence on subsistence agriculture, small entrepreneurial skills, inadequate infrastructure), and identified strengths in Romania (high value natural resources, rich cultural heritage, etc.).
- Axis 4 "Leader" aims to support rural development through improved local governance and promotion potential. Leader approach will help achieve the objectives of Axis 1, Axis 2 and Axis 3 through integrated local development strategies and innovative actions.⁶

In the National Rural Development Programme 2007-2013 of Romania, the public contribution is 10.097.083.737 euros⁸, and for the four thematic axes amount of public contribution is EUR 9.095.827.844 and the value of private contribution is EUR 3.343.425.613. In the total for rural development in Romania are allocated funds amounting to EUR 13.440.509.349. Most funds are allocated for Axis 1 "Improving the competitiveness of agriculture and forestry" where 4.024.666.997 euros allocated as public contribution, followed by Axis 3 "Quality of life in rural areas" with the amount of 2.509.498.033 euros, Axis 2 "Improving the environment and the countryside" with a public contribution of EUR 2.326.587.942 and Axis 4 "Leader" to 235.074.871 euros.

Measures for which could not submit projects are: Axis 1 - measures 111 Training, information and diffusion of knowledge, 113 Early retirement of farmers and farm workers, 114 Use of advisory services, 122 Improving the economic value of forest 125 Improving and developing infrastructure related to the development and adaptation of agriculture and forestry, 143. Providing advisory and consultancy services for farmers, Axis 2 - measures 213 Natura 2000 payments on agricultural land, 221 First afforestation of agricultural land, 223 First afforestation of non-agricultural land, 224 Natura 2000 payments on forest land, 341 Skills acquisition, animation and implementing local development strategies, measures that were allocated the sum of EUR 1126165545. Most measures have not yet been opened can be found in submission of projects under Axis 1 Improving the competitiveness of agriculture and forestry and for Axis 2 Improving the environment and the countryside.

In Table 2 were performed calculations on the amount of funds allocated to the axes of which were deducted amounts for measures that were not open session for submission of projects and resulting that the axis 1, 2 and the overall total value funds allocated to date is less than the total amount allocated to the EAFRD and the maximum total European funds could be accessed until 12.31.2011 is EUR 8.970.918.192.

3. The situation in Romania on payments in the period 2007-2010

3.1. Status of accessing European funds for rural development 31 May 2009

For measures launched at national level have been submitted 13 338 projects in accordance with a value of public about 5.062 billion euros, representing approximately 63.10% of the total amount allocated to Romania for rural development for 2007-2013 (67.30% if we refer to the 7.522 billion euros for rural development remaining after allocation of 500 million euros for direct payments).

Ten sessions were organized selection for measures launched, which included a number of 6235 projects worth about 5 billion euro. Of these were selected for funding 2548 projects worth 1.627 billion euros, representing about 21.6% of the net amount allocated, of which there were a total of 1794 contracted projects worth 918 million Euro public, which represents approximately 12.2% of the net amount allocated. and were declared a total of 158 completed projects.

For contracted projects, 620 were paid payment request with a public value of 56.9 million, plus payments for the measure 511 - Technical assistance worth 402,317 euros and additional payments made by APIA (Measure 611), in amount of Euro 185,427,914, thus leading to a total of 242,738,892 euros of payments, which represents 3.23% of total net amount awarded by the European Union to our country.⁹

3.2. Status of accessing European funds for rural development on 31 December 2010

On 31.12.2010 were submitted 54.803 projects with a public value EUR 12.930.750.914 of which 28.646 were selected for projects with a value of 3.822.572.103 euros and ended 23.557 projects worth 3.445.452.174 euro.¹⁰

As shown in the Table above, payments up to 31.12.2010 have a value of 1.781.758.869,24 euro representing a rate of 17.65% of the total public contribution for the period 2007-2013, which only in 2010 were made payments amounting to 1.005.792.956,02 euro, representing 9.96% of total public contribution. Of the four main axes, for Axis 2 Improving the environment and the countryside meets the highest level of execution of payments at a rate of 23.52% of the total, followed by Axis 1 Improving the competitiveness of agriculture and forestry a rate of 15.09% (but with the highest value of the four axes of payments in the amount of 607.463.995,6 euros), Axis 3 Quality of life in rural areas, with 8.89% and Axis 4 Leader with 2.03%. Given that the first session for submission of projects took place from March 3 to 28, 2008, we can consider that Romania has a relatively high level of payment for rural development.

The table below summarized the situation by reporting payments to the value of the total public contribution and the amount of public contributions allocated for open submission project measures on 31.12.2010.

According to data calculated in Table 4 shows that the absorption of the entire program at the end of 2010 is at a rate of about 17.65%, while an analysis on the value of payments reported on the total public contribution allocated for measures open submission project in Romania is noted that payments were made in a slightly higher percentage, almost 20%.

Conclusions

- National Rural Development Program is a funding opportunity for Romanian rural area, the public contribution amounting to 10.097.083.736 euro, of which 8.124.198.745 euro EU funds, from 2007 until 2013.
- On 31.12.2010 54 803 projects were submitted to a public value of 12.930.750.914 euro, which means a higher value projects than the total amount of funds allocated for the entire period. Of the total projects were completed 23.557 projects worth EUR 3.445.452.174, which represents a rate of 34.12% of total funds, and considering that the total value of 8.970.918.192 euros reported as was allocated to for measures that have had access, resulting 38.41%, percentage which is considered to be quite good on the following: analysis of the situation expressed accessing funds on 31.12.2010, the first session of the project application was place since March 2008 and that there are three years until the end of the submission of projects.
- Payments made up to 31.12.2010 have a value of 1.781.758.869,24 euro representing a rate of 17.65% of the total public contribution for 2007-2013, of which only in 2010 were made payments totaling 1.005.792.956,02 euro, representing 9.96% of total public contribution, and if we take into account the absorption of funds only for measures where it could be submitted projects is observed that the percentage of the making of payments is about 20%. By comparison with the situation 31 May 2009 the total amount of payments was 242.738.892 euros, which represents only 2.45% of total public contribution, we can say that Romania has a strong tendency to increase the absorption of EU funds.

From the situation analyzed in this article I consider that Romania has a high potential for accessing European funds and can achieve that until the end of the 2007-2013 National Rural Development Programme to attract almost all the amounts from the European Agricultural Fund for Rural Development. However, accessing European funds is a good opportunity for the Romanian economy and especially for agriculture to overcome the economic crisis.
